



American Equity Declares Annual Cash Dividend on Common Stock

WEST DES MOINES, Iowa--(BUSINESS WIRE)--Nov. 15, 2018-- American Equity Investment Life Holding Company (NYSE: AEL), a leading issuer of fixed index annuities, today announced that its Board of Directors has declared an annual cash dividend of \$0.28 per share to owners of its common stock. This is an 8% increase from the \$0.26 annual dividend declared on November 16, 2017. This marks the twentieth consecutive year a cash dividend has been declared and the fifteenth year in a row that the Company has increased its cash dividend.

The dividend will be payable on December 12, 2018 to shareholders of record as of November 28, 2018. There are approximately 90.4 million shares of common stock outstanding as of today.
